Editor's Note

Every year for the past four years the MIS Quarterly has published a listing of recent MIS dissertations. The initial list covered MIS dissertations written between 1973 and 1980 and has been updated annually to provide a complete, up-to-date index of the MIS dissertation literature.

The method used for identifying dissertation titles was previously described and validated.¹ Although this method ensures identification of most MIS dissertations, there will be occasional oversights. Undoubtedly, there are some we have missed this year and still others from previous years. We encourage additions to the bibliography.
